If you purchase a vehicle that has been protected by Thiefbeaters by the previous keeper it is important that you have the record updated to reflect your details.

Please complete the form in full and return it to Thiefbeaters at the address shown on the bottom of the form.

There is a one-off fee of £25.00 including VAT for administration and once we have updated the record you will receive a confirmation letter and certificate. (Your insurers will usually ask to see your Thiefbeaters membership documentation to offer a discounted premium).

There is no additional charge to you if you move house or change details on the vehicle (for instance, if you fit a personalised number plate or change the colour). You can have the details updated free of charge if you write to us or e-mail us at info@thiefbeaters.co.uk quoting your Thiefbeaters Number. (This will be quoted on your membership confirmation letter).

Methods of Payment

Change of Registered Keeper payment can be made by Switch/Maestro, Visa or MasterCard. Payment may also be made by cheque or postal order made payable to Datatag ID Limited.
